- 1. In view of the prevailing lock down situation across the country due to outbreak of the COVID-19 pandemic and restrictions on the movements apart from social distancing, General circulars viz. - 2. In compliance with applicable provisions of the Companies Act, 2013 ('Act') read with aforesaid MCA circulars the 60th Annual General Meeting of the Company is being conducted through Video Conferencing (VC) hereinafter called "e-AGM". For this purpose, the Company has appointed M/s KFin Technologies Limited (Formerly known as Karvy Fintech Private Limited) ('KFintech'), Registrars, and Transfer Agents, to provide a Video Conferencing facility for the Annual General Meeting and the attendant enablers for conducting of the e-AGM.
