Dear Sir / Madam,

In continuation of our earlier updates dated July 09, 2025, October 31, 2025, and December 31, 2025, regarding joint venture of Gabriel India Limited (“**Gabriel India**”) with Jinos Co., Ltd. a company incorporated under the laws of South Korea and having its registered office at 42, Munpyung Seo-Ro, Daeduk-Gu, Daejeon, Korea (“**Jinos**”) in Jinhap Gabriel Auto India Private Limited (*previously known as Jinhap Automotive India Private Limited*), a private limited company organized and existing under the laws of the Republic of India, having its registered office at Old No.102, New No.51, Beemanthangal Village Sriperumbudur Taluk, Kancheepuram, Tamil Nadu, India, 602105 (the “**Joint Venture Company**”) *vide* Share Subscription Agreement dated July 10, 2025 (**SSA**) and Joint Venture Agreement of even date, we wish to update you that:

- Pursuant to commercial discussions, Gabriel India and Jinos have mutually agreed to revise the equity share subscription amount proposed to be invested in the Joint Venture Company; and
- In furtherance to the aforesaid understanding, the revised subscription amount for Gabriel India in the Joint Venture Company is INR 24,11,73,695 (Indian Rupees Twenty-Four Crores Eleven Lakhs Seventy-Three Thousand Six Hundred Ninety-Five only). We confirm that the shareholding ratio between Gabriel India and Jinos remains unchanged at 51:49 respectively.

The revised subscription amount has been formally incorporated into the SSA *vide* amendment agreement dated February 3, 2026 executed amongst the Joint Venture Company, Gabriel India and Jinos. All other terms and conditions of the SSA, as amended till date, remain the same.
